## Minutes of the 709th meeting of Toft Parish Council Meeting held on Monday 5 January 2015 in The People's Hall, Toft at 7.00 pm

Present: Councillors: M Yeadon (Chairman), J McCarten, E Dolman, G Pugh, P Gouldstone, P Ellis-Evans, and A Tall.

In attendance: Mr Paul Duggan (Wiser Recycling), 7 members of the public and Mrs G Stoehr (Clerk)

#### Open public session including reports from the County and District Councillors

A resident outlined objections to the planning application for 32 High Street, namely that a detached house was not in keeping with the small plot, there would be an increase in street parking, and the old plans did not show the neighbour's completed extension.

It was observed that Balfour Beatty had failed to keep the Parish Council informed about the barriers for the street lighting works and other issues.

Mr Paul Duggan of Wiser Recycling explained the scheme for recycling electrical waste, and the benefits to the village, including a payment of £40 per tonne to the Parish Council. Collections would take place every 6-12 months.

A resident expressed concerns at the planning application for six houses in Comberton Road, and the impact on the adjacent business. It was observed that in the past, piggeries which predated the housing had been closed down.

RESOLVED that the minutes of the meeting on 1 December be approved as a true record and signed by the Chairman after the following amendments 69 High Street PC had no objections (JM, GP) Cllr Yeadon left during this item.

On a proposition by the Chairman, it was agreed to vary the order of business to take Items 6.1.1 and 6.1.2 at this point.

6.1.1 <u>S/2599/14/FL – 32 High Street – provision of a new dwelling on land adjacent to 32 High Street</u>

Cllr Tall arrived at 7.25 pm during this item.

RESOLVED that the Parish Council recommended refusal of the application. (Prop MY, 2nd TEE) There was inadequate segregated parking. A drain outside 38 High Street had been blocked for some time, indicating possible problems with drainage from overdevelopment of the site. Concerns also included the narrowness of the site and overlooking of neighbouring properties. Concerns were expressed about the road drains outside the property.

6.1.2 <u>S/2825/14/OL – Land off Comberton Road – Outline application for the erection of 6 dwellings and associated access</u>

RESOLVED that the Parish Council recommended refusal of this application, (Prop MY, 2nd JM). with the following comments:

Toft has been designated an "infill" village and it is expected to retain this status. This development is not an infill development.

The development proposed is outside the village development boundary, a boundary the Council is keen to retain.

The development is in the green belt.

The industrial site adjacent to the proposed site is a waste transfer operation, a successful business and local employer. The Council believes it is not appropriate to locate a housing development next to such a physical operation.

The Council has concerns about access across paths and cycle paths and general traffic safety concerns. There are also concerns about waste treatment.

Most members of the public left the meeting.
