RESOLVED that the minutes of the meeting on 13 April be approved as a true record and signed by the Chairman, (Prop MY, 2nd JM) after the following amendments: under Item 7.2, paragraph 6, to delete wording to read "...Kingston Parish, and quotations for their installation are to be obtained for the next meeting, and that Cllr McCarten..."; under paragraph 7, to read "bridge leads towards Eversden Parish"; under Item 7.4, paragraph 1, replace last sentence with "A nature trail for the fete is to be organised"; under Item 7.10, change 67 to 69; under Item 3.2, line 1, delete "The".

District Cllr Hawkins was invited to report:

- Toft Car park. Cllr Hawkins has taken the matter up with SCDC and the officer will look at the situation again. It was observed that on a Sunday morning four trailers, two large white vans, an old car and a low loader were occupying the car park. Work was starting at 7 am on Sunday morning. Cllr Hawkins will continue to pursue this matter.
- Overhanging hedge at 11 High Street. The hedge is overhanging the passageway, obstructing the light, and is also too high. Cllr Hawkins was asked to look into this.
- Cllr Hawkins undertook to check whether SCDC would be willing to empty any new dog waste bins on the Community Land, if they were to be located away from the road.
- Cllr Hawkins will pursue the issue of litter from the kebab van.

Cllr Hawkins was thanked and left the meeting at 8.43 pm.

7. <u>Matters Arising</u>

7.1 (3.2) Re-fixing of posts on the Green – to consider the next steps

Deferred to the next meeting to enable members to take a look and consider if low-level wooden poles, fixed to a post at either end might be suitable and where they could be placed.

7.2 (7.2) To consider quotations for installation of field gates at footpath if received

Three quotations had been sought but only one had been received. It was observed that the boards on the bridge also required replacement and that CCC were willing to fund the repairs. RESOLVED that Cllr McCarten should liaise with the Clerk about how any shortfall in funding the works might be met. Should it not be possible to obtain further funding from other sources, the Parish Council would be willing to cover the shortfall of approximately £188 to complete the works. (Prop MY, 2nd GP)

11.1 Toft People's Hall and works update

Report received at the Annual Parish Meeting. Most work has been completed, with some lighting works outstanding. A grand opening is planned for 27 June.

Cllr Tall verbally reported that disappearing white lines and potholes have been reported to CCC, the potholes in School Lane and Church Road have been filled but the northern end of Church Road is still in a poor state of repair.

RESOLVED having considered a verbal report from Cllr Tall on estimated costs of £2,500 for a speed reduction on the B1046 to write to Comberton Parish Council indicating that in principle Toft Parish Council is supportive of the proposal to share the costs, but that it needs to understand the cost implications of any actions before taking a final decision.

RESOLVED as there were other areas of concern in the village that it would not look in isolation at the B1046 but consider the village as a whole. Concerns were expressed about the High Street south of the bend and vehicles travelling in excess of the speed limit in Church Road and School Lane. A proposal by Cllr Gouldstone that a 20 mph speed limit should be introduced in School Lane, where children often play in the road, will also be considered, along with other issues.

RESOLVED that Cllr Tall should investigate the scope and cost of a village-wide speed reduction scheme and the costs of consultation and report back to a future meeting.

The concrete strip outside Firs Farm had been repaired.

11.3 Village Maintenance

RESOLVED that Cllr Tall should report to BT telephone wires which had been brought down by trees at Brookside.

11.4 Community Land report

RESOLVED to place an order for two picnic seats.

RESOLVED that the Parish Council should decide the new name for the Community Land from a list of suggestions put forward by the management team.

The management team had sought a second opinion on all the trees. It had been recommended that dead branches be removed from one oak tree, and there were two other trees which might require pollarding and cutting back respectively.

RESOLVED that Cllr Ellis-Evans will speak to Mr Harris to seek clarification regarding the exact line of the boundary between his land and the Community Land, to establish the ownership of the trees on or near the boundary, and report back to the next meeting.
