#### Open public session including reports from the County and District Councillors

District Cllr Hawkins reported on:

- The response of the Planning Inspector that the Local Development Plan Examination in Public had been suspended on account of:
  - 1. the overall strategy used in assessing sites; the emphasis on new settlements; sustainability; the lack of transparency in producing the plan; and the deliverability of Bourn Airfield.
  - 2. Housing numbers and affordability, and the implications of Northstowe only building 20% affordable housing.
  - 3. Written Ministerial Guidance produced after the publication of the Local Development Plan
- The City Deal and the proposals for a Park and Ride site
- A response was awaited from the SCDC officers regarding the car park.
