1. Apologies for absence and declaration of interests

- 1.1 <u>To approve written apologies and reasons for absence</u> Apologies were received from Cllrs Yeadon and Pugh (both out of parish).
- 1.2 <u>To receive declarations of interest from councillors on items on the agenda</u> Cllr McCarten declared an interest in item 4.7 as she had attended the sessions.
- 1.3 <u>To receive written requests for dispensations (if any) and to grant any dispensation as appropriate</u> None.

2. <u>To approve the minutes of the meeting of 4 January 2016</u>

RESOLVED that the minutes of the meeting on 4 January be approved as a true record and signed by the Chairman. ^(Prop PG, 2nd JM unanimous)

Open public session including reports from the County and District Councillors

A resident complained about the lack of visibility on turning right into Toft from Hardwick Road, due to the prominence of a fence. It was observed that the planning permission stated there would be bushes rather than fences in that location.

The rubbish bin at the walkway next to the car park appeared to be full of rubbish. District Cllr Hawkins will be asked to look into the matter.

Grass was reported to be growing onto the tarmac area at Stoney Lane, reducing the width available for walking from four feet to two, and that this needs to be cleared.

It was also reported that electricity workers had cut ivy off a lamp post and left it behind. A resident kindly offered to put it in the green bin.

The hedge on the corner at the bottom of the High Street is to be raised under item 6.3.

District Cllr Hawkins arrived at 7.15 pm.

Her report covered:

- The consultation on proposed changes to the Planning Scheme of Delegation. The Parish Council can ask for an application to go to the SCDC Planning Committee but a valid reason must be given and a Parish Council member must attend the meeting.
- Business support workshops run in collaboration with Huntingdonshire District Council, to take place between January and April.
- The SCDC Budget. SCDC need to find a further £0.4m savings. This could be achieved by an increase of £5 to Council Tax, but this will trigger a referendum or further cuts will be required. CCC need to find £46m savings.
- Housing Government changes affecting the income of private landlords and the 1% reduction of rental income for SCDC.
- Local Development Plan no further information.

3. <u>Co-option to fill casual vacancy</u>

RESOLVED that Elaine Miles be co-opted as a member of the Parish Council. ^{(Prop JM, 2nd} AT, unanimous) Cllr Miles signed the Declaration of Acceptance of Office before taking her seat.

District Cllr Hawkins left the meeting at 7.32 pm.

RESOLVED to adopt the draft allotment tenancy agreement as circulated and amended by CIIr McCarten, subject to confirmation on the numbering of the plots. ^(Prop JM, 2nd PG, unanimous)

RESOLVED to consider Councillor responsibilities at the next meeting and to appoint a lead councillor for allotments at that time.

RESOLVED that Cllr McCarten should update the agreement and send it to the Clerk.

A quotation should have been received from Nick Warner for further tree work. RESOLVED to contract Nick Warner to pollard two trees at a cost of up to £100.00. (Prop PEE, 2nd JM, unanimous)

Quotations for Lot's Meadow are to be an agenda item for the next meeting.

4.4 (6.4) To consider whether the Parish Council wishes to commemorate the Queen's 90th birthday

RESOLVED that Cllrs Gouldstone and McCarten should speak to the Church and Social Club respectively to find out whether they have any plans, and if so, whether they wish to apply to the Parish Council for funding, This is to be an agenda item for the next meeting.

4.5 <u>To consider Comberton Parish Council's request for 50% contribution to cost of ditch</u> <u>clearance behind the school houses</u> RESOLVED given that this was agreed in principle at an earlier meeting, to pay half the

RESOLVED to write to SCDC asking them to locate a dog bin at the entrance to Pinfold Well Lane on School Lane.

RESOLVED, given that the dog bin at the bottom of Toft Wood (Miller's Road entrance) was still off its post, to pursue this with SCDC.
