Minutes of the Toft Annual Parish Meeting held on Monday 8 May 2017 in The People's Hall, Toft at 7.00 pm

Present: 11 Parishioners including Councillors M Yeadon, P Ellis-Evans, J McCarten, E Miles, G Pugh and A Tall, District Cllr Tumi Hawkins, County Cllr Lina Joseph and Mrs Gail Stoehr (Clerk).

1. <u>Apologies for absence</u>

Apologies had been received for possible lateness from County Cllr Lina Joseph.

2. <u>To approve the minutes of the last Annual Parish Meeting held on 9 May 2016</u> The minutes of the meeting on 9 May 2016 were approved as a true record and signed by the Chairman.

3. <u>Matters Arising</u>

Any matters arising will be covered in the Chairman's report.

4. <u>Report of the Parish Council for the year¹</u>

Councillor Yeadon presented his report, which is appended in full to these minutes. The Chairman thanked the Councillors for their support and hard work, and outlined their members' responsibilities. There is currently a vacancy for a councillor. The report covered:

- the Queen's 90th birthday street party; the Sports Day, and financial support for the annual firework display.
- Highways matters including the speed limit between Comberton and Toft, signage, yellow lines by the village green and the speed reduction scheme
- The Community Highway Volunteer Scheme for simple maintenance
- Relocation of the dog bins
- The Community defibrillator project
- The Council taking over responsibility for the Allotments following the closure of the William Worboys Charity, and funding received from the Ramblers' Association for a new bench
- Planning matters including the Bennell Farm development, development on the west side of Hardwick Road, the change of use for the restaurant and membership of the Coalition of Parish Councils and its work.
- The listing as Assets of Community Value of the shop and the restaurant.
- The management of the Council finances; the precept had remained the same.
- The Village Hero Award for Martin Sebborn.

A question was asked about the website and Parish Council papers. The Clerk will look into the matter.

A resident encouraged the Parish Council to let the residents know when the accounts were published.

County Cllr Lina Joseph arrived at 7.24 pm.

5. <u>Presentation of the Council's audited accounts and financial report²</u>

The report of the Clerk and Responsible Financial Officer, Gail Stoehr, was read and the audited accounts for the Financial Year ended 2016 were presented and a copy is available on request. With regard to the City Deal, Cllr Hawkins was asked whether the inspector required new modelling for the transport plan. This may possibly be in July.

- Drainage and sewage issues
- Toft Car park
