# Minutes of the 753rd meeting of Toft Parish Council Meeting held on Monday 3 December 2018 in The People's Hall, Toft at 7.00 pm

#### Open public session including reports from the County and District Councillors

A resident commented on the condition of the pavements on the High Street near Chapel Cottages and on the way to Comberton. The encroachment of gravel from driveways on to the pavement was also raised.
