District Cllr Chamberlain reported that the consultation on the Waterbeach development was due shortly and a decision on the transport corridor on the route from Cambourne to Cambridge was due in February or March. He expressed the hope that funding would be provided for the Bikeability scheme.

A letter from a resident, which had been passed to Cllr Chamberlain, about registration of protected village amenities under the Local Plan, is to be agenda items for the next meeting.

New Constitution of William Eversden's Charity, adopted by the Trustees of the Charity on 2018

1. Name

The charity's name is William Eversden's Charity.

2. The purpose of the charity

The Toft Allotments were entrusted to this Charity after a gift made in 1730 from William Eversden. The purpose of the Charity is to administer the Toft Allotments for the benefit of the inhabitants of Toft (in Cambridgeshire) and its surrounding areas.

3. Custodian Trustee

The Toft Allotments are registered at HM Land Registry under title number CB434495 and the registered proprietor is the Official Custodian for Charities.

4. Corporate Managing Trustee

The Charity is managed by Toft Parish Council acting as the Corporate Managing Trustee.

5. Carrying out the purposes

In order to carry out the charitable purposes, the Corporate Managing Trustee has the power to:

- (1) Let or rent the allotments to individual plot-holders on terms and conditions approved by the Corporate Managing Trustee
- (2) raise funds, receive grants and donations
- (3) apply funds to carry out the work of the Charity
- (4) co-operate with and support other charities with similar purposes
- (5) do anything which is lawful and necessary to achieve the purpose of the Charity

6. Annual General Meeting

Every person who is a plot-holder of an allotment managed by the Charity is entitled to attend an Annual General Meeting of the Charity which must be convened by the Corporate Managing Trustee.

7. Meetings of the Corporate Managing Trustee

(1) The Corporate Managing Trustee must hold at least one meeting each year (in addition to the AGM).

- (2) At least three individual members of the Corporate Managing Trustee must be present at each meeting to be able to take decisions.
- (3) The Corporate Managing Trustee may generally act by simple majority decision, but any decision to change this constitution or to wind up the Charity requires a two-thirds majority
- (4) Minutes shall be kept for every meeting.
- (5) If any individual member of the Corporate Managing Trustee has a conflict of interests, they must declare it and leave the meeting while this matter is being discussed or decided.
- (6) The Corporate Managing Trustee may make reasonable additional rules to help run the Charity. These rules must not conflict with this constitution or the law.

8. Money and Property

- (1) Money and property must only be used for the Charity's purposes.
- (2) The Corporate Managing Trustee must keep accounts for the Charity which are completely separated from Toft Parish Council's own accounts. The most recent annual accounts of the Charity can be seen by anybody on request.
- (3) Neither the Corporate Managing Trustee nor any individual member of the Corporate Managing Trustee can receive any money or property from the Charity, with two exceptions:
 - (a) individual members of the Corporate Managing Trustee may become plot-holders of allotment plots, just as any other local inhabitant may; and
 - (b) reasonable out of pocket expenses may be refunded to individual members of the Corporate Managing Trustee.
- (4) Money must be held in the Charity's own bank account.

9. Changing this Constitution and Winding Up the Charity

- (1) If the Corporate Managing Trustee considers it is necessary to change the constitution, or wind up the Charity, they must call a general meeting of the allotment plot-holders and listen to their opinions before making the decision.
- (2) If the Charity is to be wound up, any money or property remaining after payment of debts must be given to a Charity with similar purposes to this one.
- (3) No change to the constitution can be made that would make the organisation no longer a charity.

William Eversden's Charity

Resolution of the current trustees, transferring the management of the Charity to Toft Parish Council

We, the two remaining trustees of William Eversden's Charity, have today agreed unanimously to adopt the attached new Constitution for the Charity and thereby to transfer the management of the Charity to Toft Parish Council, which will act as a Corporate Managing Trustee.

We make this change in the constitution of the Charity because it is in the best interests of the Charity to do so.

We are not changing the purpose or objects of the Charity at all.
