My clients propose to submit a planning application to South Cambridgeshire District Council for residential development on this site. The tree above has some rot at the base and in the primary root system on the South East side which is heading towards the road. Although a reasonable amount of reaction wood has been produced on the North West side of the trunk, due to the trees location and lean, i would recommend its removal. If a removal is out of the question then a crown reduction of approximately 1.5-2 meters would be an appropriate course of action for the near future. The cost for either a removal or reduction would be £80.00 plus VAT
