Toft Parish Council would be grateful if you could investigate and take any action you consider necessary. Thank you.

PRoW, footpath-140/6, Parish: Kingston

The footpath leads onto the B1046 and crosses a field in which horses are kept. The owner of the horses drives onto this field from the B1046 to deliver food for the horses and this has churned up the verge and access to the footpath making it hazardous to walk on."

Eversden Parish Council has confirmed that the area is not in their parish.

Kingston Parish Council received the following reply from CCC:

"This is a short note to let you know that I inspected the Public Footpath this morning. There is a deep wheeling on the bridge parapet side of the track to gate and this is in the soft verge. Sufficient width that is firm and level is available for the public to use along the track. Around the area of the kissing gate does not have any major problems such as poaching by horses.

In this instance there is no further action required as the publics' right to use the Public Footpath has not been unfettered by the rut in the verge. Thus, we will close this particular report.

Thank you again for reporting the problem."

In May the Parish Council decided to review the issue relating to the horses later in the year.

The publication of the new Definitive Map and Statement, which shows all changes made to Public Rights of Way up to 11th May 2016 will be advertised via a public notice in all local newspapers as well as through a press release. Communications are also being sent to all local user group representatives. Cllr Anna Barford of Comberton Parish Council has written to Cllr Tall as follows:

"I wanted to ask how your speed reduction plans are going, and if you know how much you need from us?

We have £1250 earmarked to contribute towards the section of road from Toft to Comberton becoming 40 mph. Budget code: 160714/17 TWG

It would be great if you could let me know whether you need the full amount, just so I can work out our budgets going forward.

Also, we have now finalised a proposal for speed reductions in Comberton. Is there any chance that you might be able to present it to your Parish Council please? I've attached a map showing our proposal. If the Toft PC were able to support this, it would be wonderful to receive a letter of support to help with our own LHI bid. I can provide additional information if that would help."

Toft Capital Investment Plan

The following table lists the potential projects that would provide improved facilities within the village.

The PC only has limited land and additional land would be needed to achieve some of the proposals, in particular the Tennis Court and New Cemetery Site. The following village map shows potential locations for this projects. It is important to note that in putting together the map of locations no thought has been given to land ownership, land availability, or any planning issues.

Defibrillator Equipment for Toft

During the summer we visited two villages where the Parish Councils had recently installed defibrillators.

1. The Community Heartbeat Trust (CHT)

We met with the Parish Clerk and the Chairman of the Parish Council at Little Paxton. They have 3 defibrillators in locked cabinets as the village is quite large (approx. population 3,000). These were installed earlier this year and they used CHT to assist them in the process. CHT were very helpful every step of the way. After installation they provided one training session per defibrillator free of charge which is led by a CHT representative. The PC funded their purchase through the Lottery. They have offered us some spaces to attend their next training session on 15th October as well as assistance in completing the Lottery funding application.

2. British Heart Foundation (BHF)

In Guilden Morden we met with the Parish Councillor tasked with their defibrillator project. Guilden Morden is a much smaller village than Little Paxton but larger than Toft. They have recently installed a defibrillator outside their village hall. The cabinet and defibrillator were provided free through a government funding scheme. Due to high demand this funding scheme has now been closed and will only open again if the government decide to give it more money. The Guilden Morden cabinet is not locked. Insurance is provided via the Parish Council insurance policy. The BHF provide training via DVDs which explain the use of the defibrillator, resuscitation and CPR. They also provide dummies to practice on.

Costs for a CHT supplied Defibrillator

Defibrillator & cabinet - £1,800 - £2,000 + VAT

Electrical Installation - £150 + VAT

Electricity cost per annum - £10

Membership which includes replacement pads (see note below) & batteries - £126 per annum + VAT

OR

Pads (required after use or every 2 yrs) - £30 + VAT + carriage

Batteries (replaced every 4 yrs) - £220 + VAT + carriage
